Apparently there is another leak and Hunt (AEC) plans to move in a rig on August 31, 2002 to repair this casing leak according to the following procedures:

MIRU Workover Rig.
Pull rods and tubing.
TIH with packer and bridge plug.
Locate casing leak. Isolate leak.
Squeeze casing leak with cement. POOH with packer.
TIH with bit and scraper. Drill out cement.
Test casing to 1000#.
TIH and retrieve bridge plug.
Run tubing and rods.
Return well to production.
