Spud well 11-12.91. Ran 43 joints of 8 5/8" 24# casing and set at 1870' with 600 sacks of Class "C" cement. Circulate to surface. Waited on cement 11 hours. Tested casing to 800 psi. Held OK.

Ran 144 joints of 5 1/2" 15.5# casing and set at 6500' with 1400 sacks of Class "C" cement. Circulated cement to surface. Waited on cement greater than 24 hours. Tested casing to 2000 psi. Held OK. Total depth 6500'.
