Spud well 6-21-92. Ran 32 joints of 8 5/8" 24# casing and set at 1335' with 500 sacks of Class "C" cement. Circulate to surface. Waited on cement 10 hours; however, compressive strength meets minimum requirements. Tested casing to 800 psi. Held OK.

Ran 112 joints of 5 1/2" 15.5# casing and set at 5145' with 1100 sacks of Class "C" cement. Circulated to surface. Waited on cement greater than 24 hours. Tested casing to 2000 psi. Held OK. Total depth 5145'.
