Spud well 6-13-92. Ran 31 joints of 8 5/8" 24# casing and set at 1310' with 500 sacks of Class "C" cement. Circulate to surface. Waited on cement 9 hours; however, compressive strength meets minimum requirements. Tested casing to 800 psi. Held OK.

Ran 141 joints of 5 1/2" 15.5# casing and set at 6440' with 1500 sacks of Class "C" cement. Circulated to surface. Waited on cement greater than 24 hours. Tested casing to 2000 psi. Held OK. Total depth 6440'.
