11/15/93: Drilled 11" hole to 4753'. Ran 108 jts. 8 5/8" 32# S-80 and J-55 casing set at 4753' KB. Cemented with 550 sx Class "C" 35/65 Poz cement containing 3 lbs/sx salt and 1 lb/sx Gilsonite followed by 200 sx Class "C" cement containing 1% CaCl<sub>2</sub>. Plug down at 6:00 p.m. 11/14/93 with 1500# maximum pump pressure. Wait on cement 12 hrs. Ran temperature survey. Top of cement at 1950'. Tested BOP's and 8 5/8" casing to 1500# for 30 minutes, tested okay. Commenced drilling 7 7/8" hole at 6:00 a.m. 11/15/93.
