Section 20 17S 33E


Caprock Maljamar Unit #193

These wells will more efficiently and effectively establish the pattern of the waterflood as set out by Order No. R-10094.

Attached are copies of the C-101, C-102, map showing existing wells, proposed wells and proposed access roads and plat of the waterflood area showing the original 80-acre 5-spot waterflood patterns. It is anticipated that the injection pattern will become a 40-acre 5-spot pattern.
