Unit J, Section 17 17S 33E

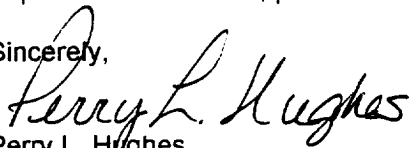
Caprock Maljamar Unit #195

These wells will more efficiently and effectively establish the pattern of the waterflood as set out by Order No. R-10094.

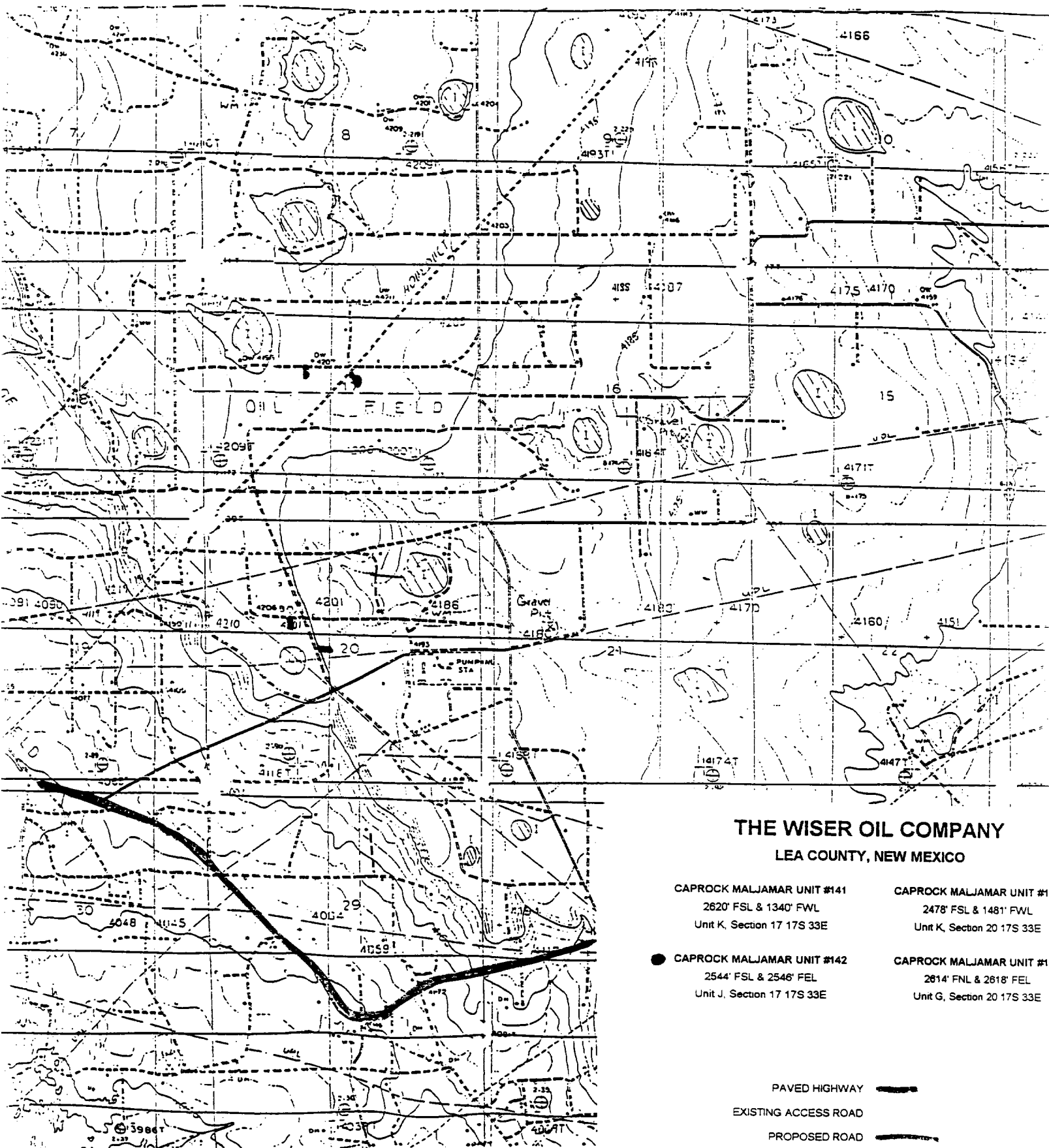
