

5/18/95 Drilled to TD of 11,490'. After logging, it has been determined that the wellbore deviated to a bottomhole location approximately 280' north and 13' east of the surface location. In order to penetrate the Strawn Lime at a more favorable position, the well must be sidetracked to a proposed bottomhole location approximately 60' north and 10' west of the surface location. This will still be an orthodox location. Verbal approval to sidetrack to this bottomhole location was given by Mr. William LeMay on May 18, 1995.
