10-17-96: Set 9 5/8", 40#, L-80 casing @ 4618'. Cemented with lead slurry 950 sx, CI C + 16% gel + 3% salt + .3% CD-32 + .2% SM. Tail slurry of 1130 sx CI C + 2% BA-90 + 3% salt + .3% CD-32 + .2% SM. Circulated 100 sx to surface. WOC.
