Yates Petroleum Corporation proposes to drill and test the Morrow and intermediate formations. Approximately 450' of surface casing will be set and cement circulated to shut off gravel and cavings. Approximately 4600' of intermediate casing will be set and cement circulated. If commercial, production casing will be run and cemented, will perforate and stimulate as needed for production.

MUD PROGRAM: 0-450' FW Gel/Paper/LCM; 450'-4600' Brine; 4600'-9400' Cut Brine/Starch; 9400'-12600' Salt Gel/Starch.

BOPE PROGRAM: BOPE will be installed on the 8 5/8" casing and tested daily for operational.
