Propose to set CIBP @ 6840' and dump 35' cement on plug. Perforate squeeze holes near TOC (6740') and pump 150 sx Interfill C followed by 110 sx Super H to bring TOC to approximately 2600'. Perforate Delaware 6714-6730', acidize, and possibly frac. If well is not sufficiently productive, set CIBP @ 6700' and dump 35' cement on plug. Perforate Delaware 5694-5716', acidize, and frac.
