Ran 7 joints 13 3/8" 35.6# Spiral Weld casing. Set 281' at 297'. Cemented with 250 sacks 50-50 Pozmix, 2% Calcium Chloride. Plug down 8:00 a. m. 1-2-61. Cement circulated. After 24 hours, pressured casing with 1000 psi for 30 minutes, no decrease in pressure. Drilled cement and shoe, pressured up with 800 psi for 30 minutes, no decrease in pressure.


