DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On November 2, we dumped a 10 sack cerent plug on bottom @ 4715'; filled the hole back to 3961' with mud and set a bridge. We put 10' of gravel on the bridge back to 3951'. We then dumped 3 sacks of cement and this filled back to 3936'. We then dumped 180 qts. of gelatin back to 3916'. We placed 200' of gravel tamp on top of shot. Well was then cleaned out and on a bailing test made 27 bbls. of oil per day. On December 7, we set a 10 sack Cal-seal bridge with the top @ 3815'. On December 8, we ran 3813' of 7" 20# smls. casing and cemented with 100 sax by Halliburton. Cement was allowed to set for 72 hours; plug drilled and cement job was all right.
