## DETAILS OF WORK

We will run approximately the following casing programs:

3000 feet 8 5/8" O.D. casing, cemented with 250 sacks cement.

8850 feet 5 1/2" O.D. casing, cemented with 300 sacks cement.

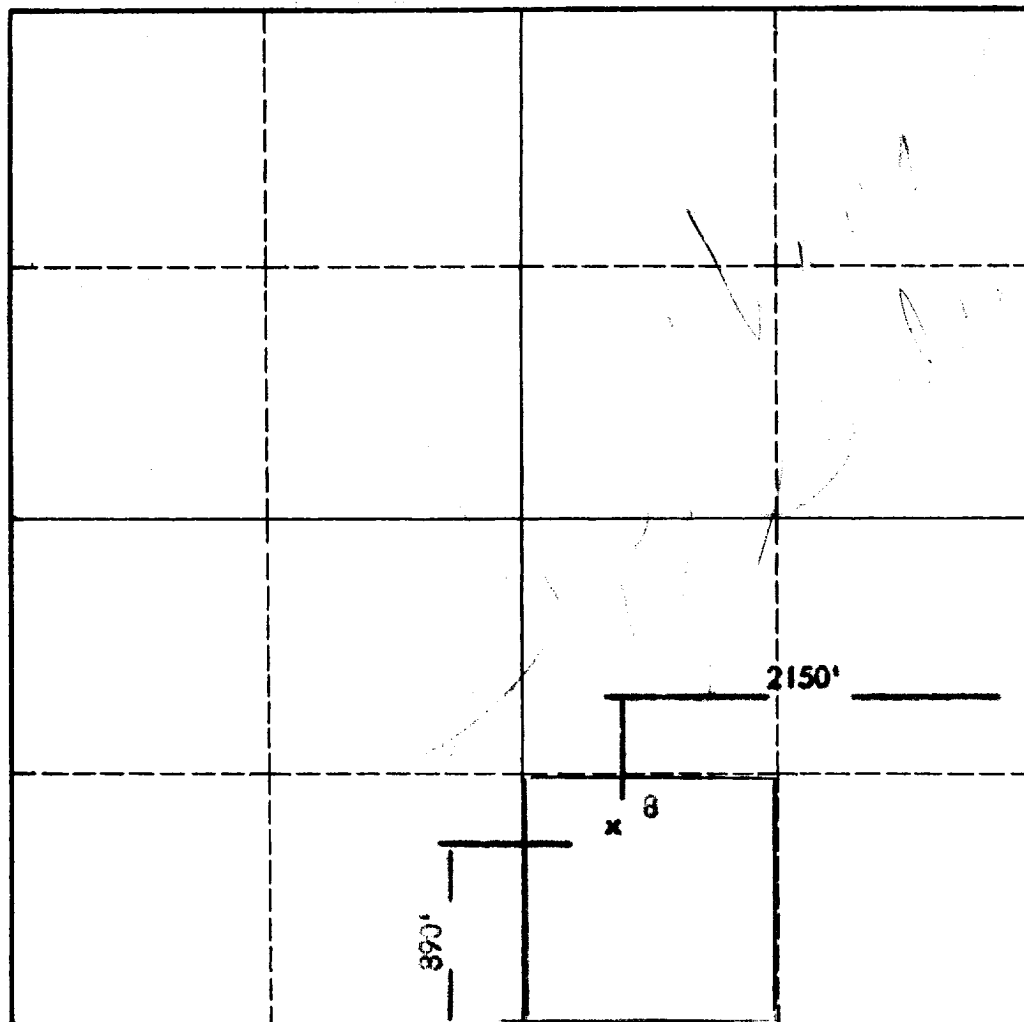
