FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

To increase production we propose to do the following work:

1. Pump well down and inject a mixture of 55 gallons of Cheplex in 500 gallons of 5 percent hydrochloric acid into the tubing-casing annulus.
2. After 24 hours, pull rods and tubing.
3. Plug back open hole from 4680' to 4650' (30') with hydromite as insurance against fracturing into water.
4. Fracture open hole from 4348' to 4650' with 30,000 gallons of refined oil carrying one pound per gallon of sand in 10,000 gallon stages with 1000 pounds flaked naphthalene between stages down 3-inch tubing with packer set at approximately 4300'.
5. Recover load oil, test, return well to production.
