1. Pull tubing, and dump sand to fill up to 3925' if necessary.
2. Squeeze perforations at 3907' & 3912' with 100 Sx. cement. Drill out cement and clean out to packer.
3. Retrieve packer, re-run pump equipment, Test, and place well on production.
