Total Depth - 1575' - Anhydrite.


Set and cemented 1546' (75 jts) of 8-5/8" OD 28# Lapweld Casing at 1559' with 200 sacks on bottom. Ran 140' of 1" tubing and circulated with 100 sacks of cement at top. Completed cementing casing at 1:15 AM 6-10-40.

Drilled plug 1:45 AM 6-12-40, and tested casing shut-off with 1000#-Tested OK
