(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

1. Spot 20 sx. cement from 3155' to 2950' inside 4 1/2" OD casing.
2. Cut and pull 4 1/2" OD casing at approximately 2500'.
3. Spot 25 sx. from 50' below to 50' above top of cut off 4 1/2" OD casing.
4. Spot 30 sx. from 1650' to 1550' (over surface casing seat).
5. Spot 15 sx. at surface inside 8 5/8" OD casing.
6. Leave 8 5/8" head so well can be re-entered and made a water source well.
