Set and cemented 1675' of 8-5/8" O.D. 28# Lapweld casing at 1688' with 200 sacks on bottom. Ran 140' of 1" pipe behind casing and circulated with 100 sacks. Completed cementing at 7:40 a.m. today (12-4-40).

Drilled plug 7:40 a.m., 12-6-40, and tested casing before and after with 1000# and tested O.K.
