FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

We request permission to use central tank battery to receive the production from the following wells: State of New Mexico "AA" (Lease No. 62642) Well No. 1, located in the NE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Sec. 3 T-18-S, R-34-E and State of New Mexico "X" (Lease No. 55278) Well Nos. 1 & 2, located in the N $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Sec. 3, T-18-S, R-34-E.

This common tank battery will be located on the state of N. M. "X" Lease in the NE $\frac{1}{4}$ of Sec. 3, as shown on the attached sketch and will receive the production from the above wells, (this portion of both of the above leases are Lieu Land). This central tank battery will include adequate tankage and other equipment, so that the production from each well can be accurately determined at able intervals.
