1-18-56 4439' TD. Ran 141 jts (4452.74') of 5 1/2" OD, 17#/ft, J-55 casing, including Baker Float Shoe and collar. Gist centralizers at 4420' and 4340'. Casing set at 4434.50' with 300 sacks of 4% gel and 100 sacks of regular neat cement. Plug down at 6:48 PM. WOC.

1-19-56 At 1:00 AM ran temperature survey - found top of cement at 2865'. Top of plug in casing at 4417'. Tested casing with 1500# for thirty (30) minutes - held OK.
