Halliburton Oil Well cementing Company cemented with 700 sacks 50-50 Pos. Incor with 6% gel and 100 aks. Incor Neat with 2% calcium chloride.

The top of cement outside casing found at 2990' above base of salt. After 24 hours W.O.C. casing was tested with 1800# for 30 minutes with no loss of pressure.
