6-25-56 4477' TD. Ran 119 jts 5 1/2" OD 17# J-55 casing with Baker shoe and collar - 4435.96' net. Set at 4454' with 300 sks 4% gel (13#/gal) and 100 Sks regular neat (14.8#/gal). Plug down at 2:30 AM 26th.

6-26-56 Ran temperature survey and found top of cement at 2090' outside 5 1/2" casing. Top plug inside casing at 4377'. Drilled out cement and float collar 4394 - 4445'. Tested casing with 1000# for thirty (30) minutes -- held OK.
