DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

7-3-56 Spudded 12" hole @ 1:50 AM. Drilled to 367' TD, finished at 6:35 AM. Ran 11 jts 8 5/8" OD J-55 24#/ft casing with float shoe. Total 349.29'. Set @ 365.22' with 260 sks Longhorn regular neat. Slurry weight 15.3#/gal. Stopped plug @ 335'. Used 21 1/2 bbls water displacement. Maximum pump pressure 500 psi. Plug down @ 9:28 AM. Circulated out 100 sks.

7-4-56 Tested casing @ 330' to 1000 psi before drilling out. Held OK. Tested at 375' to 1000 psi after drilling out. Held OK. Commenced drilling plug @ 3:30 PM.
