Full rods & pump. Clean out to TD (4686'), set RTTS tool near bottom 5½" casing (4200'). Acidize with 2,000 gallons NE acid, and frac through 2½" EUE N-80 tubing with 30,000 gallons refined oil with 1# sand per gallon, in two equal 15,000-gallon stages, separated by 1000# TLC-15 (diverting agent). Return to pumping production.
