DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

We attempted to swab water from casing with casing swab but same produced such heavy vacuum in its wake that it became necessary to empty hole by bailing. Hole was bailed down to top of cement and casing tested. Same was found to be OK. Cement was then drilled from casing and hole cleaned to bottom at 4664'. Approximately 1200' of oil is standing in hole at this depth.
