Set and cemented 8-5/8" OD seamless casing at 884' with 200 sacks on bottom. Ran approximately 140' of 1" pipe at top and circulated 100 sacks behind casing. Completed cementing 11:45 A.M. 6-28-44.

Drilled plug at 3:30 PM 6-30-44. Tested casing by pressure method using 1000# pressure, before and after drilling plug. Tested O. K.
