1. Pull & lay down cement lined tbq.
2. Clean out open hole to 4413'
3. Acidize w/500 gals. acid & fracture stimulate w/10,000 gals. gelled Kcl & 16,000# 16/30 sand.
4. Run Salta lined tbq. & pkr. to 4300'±.
5. Test csg. to governmental requirements.
6. Begin water injection.
