The well was originally drilled and completed by Joseph I. O'Neill, Jr. during 1955 as a Queen sand producing well. O'Neill plugged and abandoned the well on 10/22/65 as per NMOCC files.

On 12/5/68, W. O. Harrington filed a Notice of Intention to re-enter the well with NMOCC. Harrington apparently made an unsuccessful attempt to re-enter the well but filed no evidence of this work with the NMOCC, although a temporary abandonment report was filed.

Millard Deck Oil Company obtained a lease on the acreage on which the subject well is located on February 8, 1973, but made no attempt to re-activate the well.

Effective March 1, 1974, Armer Oil Company acquired the subject well and acreage from Millard Deck Oil Company.

On May 6, 1974, Armer Oil Company ran tubing with bit into 5-1/2" OD casing apparently
