DETAILS OF WORK

It is our intention to drill a well with rotary tools at the above location to a total depth of approximately 4,800'. All casing points will be cemented in accordance with approved methods of the U. S. Geological Survey and any other special requirements will be complied with.

It is planned to use the following casing pattern: 11" hole to be drilled, 8 5/8" casing to be set at approximately 400' and cemented with 225 sacks, cement to be circulated. 7 7/8" hole to be drilled, 5 1/2" casing to be set at approximately 4,800' and cemented with 1500 sacks. It is calculated the cement for the 5 1/2" casing will return to 1,700'.

Approval to produce this well upon completion is also requested.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

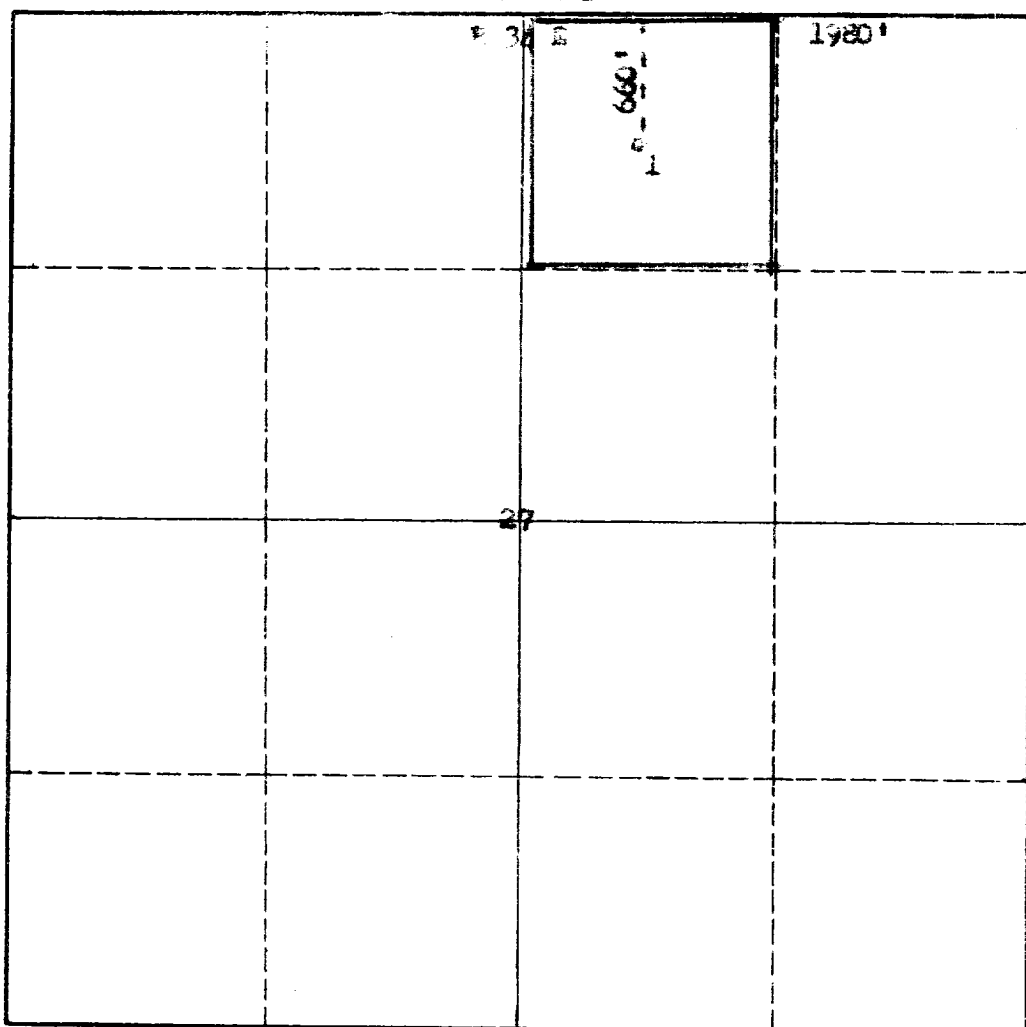
