We propose to re-enter well and complete in the following manner.

1. Drill out 10 sk plug at surface, 25 sk plug at 2888'.
2. Dress 5 1/2" casing at 2888' and drill out 25 sk plug at 4832-44 and circulate mud out of hole from C. I. B. P. at 5200'.
3. Perforate San Andres section at 5062'-72'.
4. Treat w/1000 gallons 15% HCL Acid and swab test.

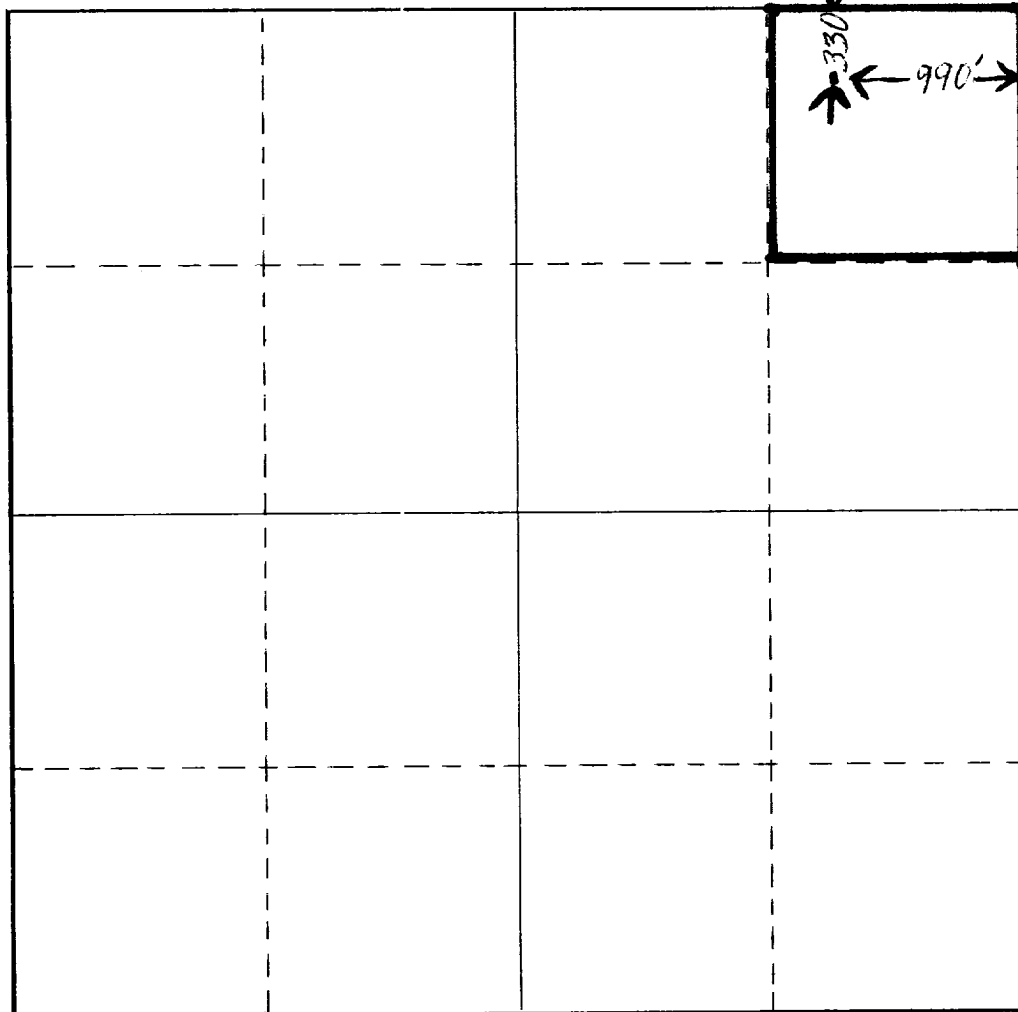
