Drilled 7-7/8" hole to total depth of 3100'. Cemented 1-1/2", 15.5', and 17' /ft, J-55, STC new casing at 100' with 440 sx. 40% "acel" cement followed by 250 sx neat cement. Plug down 3100' 7-21-61. After waiting on cement 8 hrs., cut off csg and nipple up tubing spool. Found top of cement at 3100' by temperature survey. After total 17 hrs. waiting on cement, pressure tested 1-1/2" casing with 1500 psi for 30 minutes 64. sig released 7-2-61. Perforated 3274-90, 3904-14, 4921-29, 5934-42 & 6954-60 with 2 jets per ft. Great performance interval w/6000 gals. 1.5% HCl acid. After recovering all load oil, lwd 232' 76' in 24 hrs, 14/64" ck. G.P. 625, 3.2 x 108 876 ft. prev. bbl.
