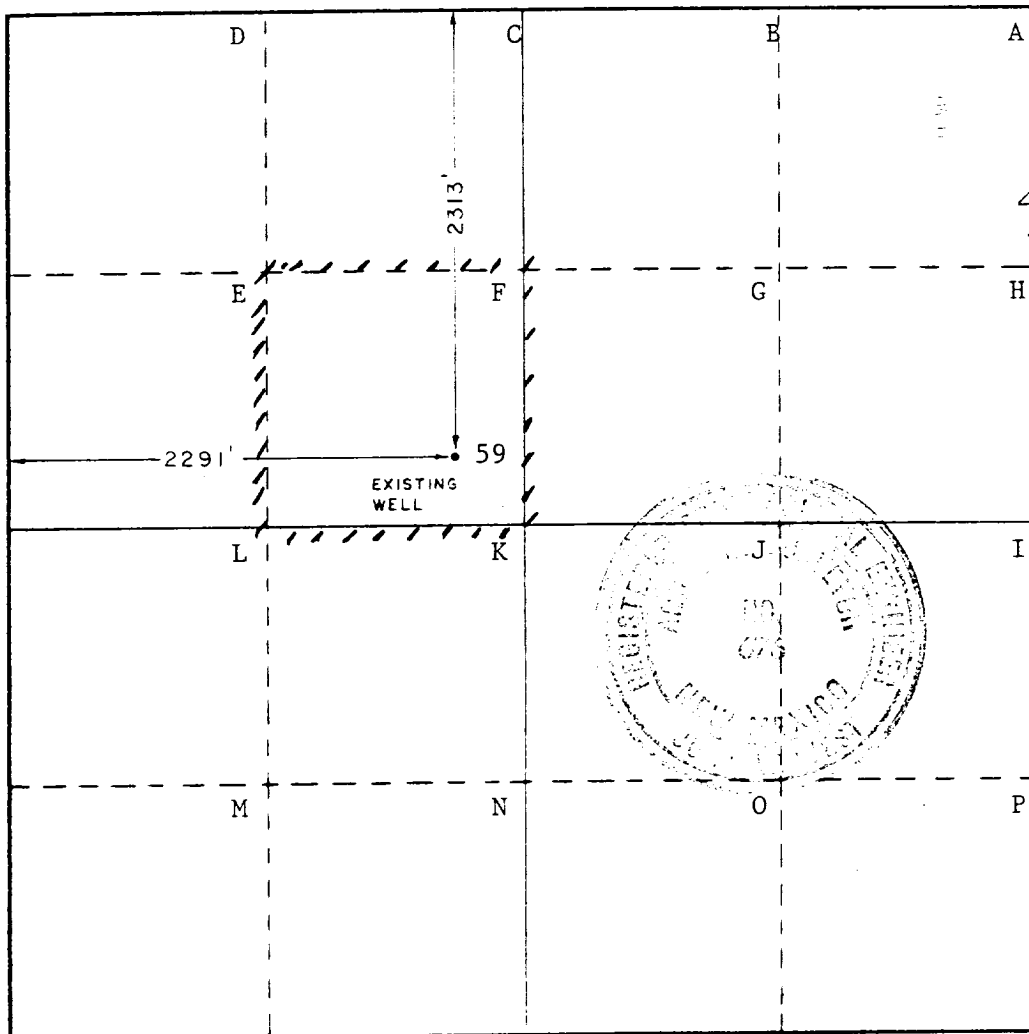

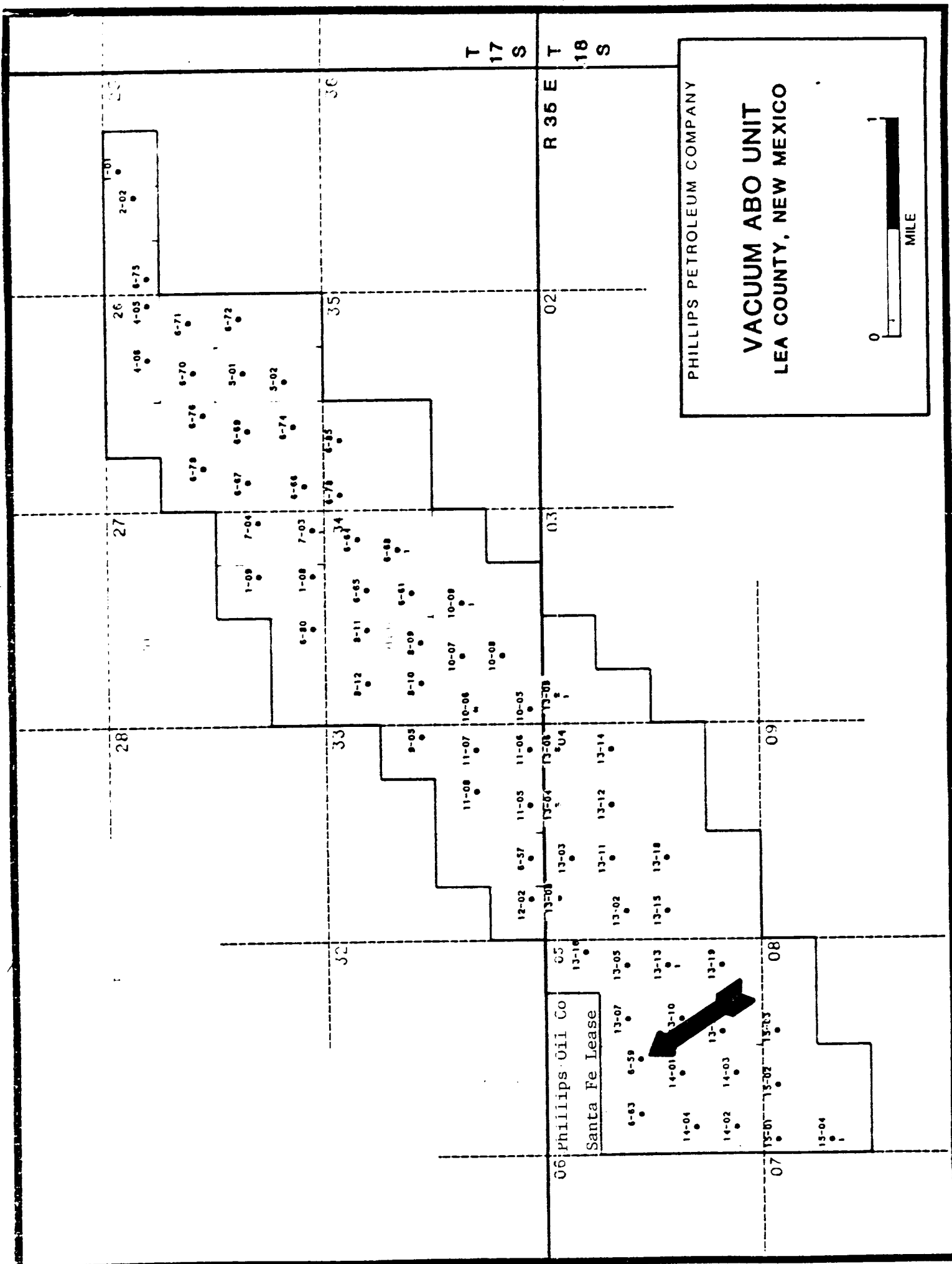

We respectfully request administrative approval for the unorthodox location of the Phillips Petroleum Company operated Vacuum Abo Unit, Btry. #1, Tr. #6-I, Well No. 59 in the Vacuum Abo Reef Pool. This well was permitted and drilled at a record orthodox location in Unit F, 2,310' from the north line and 1,980' from the west line of Section 5, T-18-S, R-35-E, Lea County, New Mexico on July 26, 1961. During recent survey work for a new power supply and electrical distribution system, it was discovered the subject well is located in Unit F, 2,313' from the north line and 2,291' from the west line of Section 5, T-18-S, R-35-E, Lea County, New Mexico.


