2. Perforated thru tubing 8758' - 8816', 8734' - 8750', 8690' - 8708' w/1 JSPP.
3. Lowered tubing 7 joints & hung @ 8809' open ended. (281 jts. (8799') 2" tubing, 5 jts. (156') T.P., 2" tubing stop @ 8656', Sweet HD-100 packer @ 8653', Sweet HHD @ 8647', 2' sub on HHD, 6' sub under hanger.)
4. Treated via tubing w/6000 gallons 15% NE acid.
5. Recovered load.
6. On OPT flowed 322 BOPD, cut 0.4% B3&W, thru 16/64" choke. FTP 775 psi. CP packer. Gr. 40.2 deg. API.


