5. Squeeze perms @ 1008' w/a total of 500 sx Class 'C' cement squeezing inside & outside of 5-1/2" csg.
6. Spot 25 sx. cement plug 700-400'.
7. Spot 10 sx. cement plug 100' - Surface.
8. Install Dry Hole Marker. Clean location. Well P&A, 6-2-80.
