FULL DETAILS OF PROPOSED PLAN OF WORK (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

We propose to do the following work on subject well:

- 1. Pull rods and tubing, set Cast Iron bridge plug at 7950", dump 4 gal hydromite on plug.
- 2. Perforate 2 7/8" Casing with two jet shots at 4648, 4649, 4650, 4651, 4677, 4677, 4679, and 4696.
- 3. Acidize with 1500 gals 15% NE acid in three 500 gal stages with eight ball sealers between each stage. (Frac with 15000 gals refined oil and 15000 lbs sand if necessary)
- 4. Swab, Test, return well to production.
