Ran 140 jts of New 8 5/8" OD 24 & 32# SR H-40 & J-55 SS casing or 4427.86' set @ (4449'). Cemented w/1500 sacks 50-50 posmix ; plus 250 sacks neat. Cement circulated, plug down 10:A.M. 1-8-62. Waited on cement 48 hours, Tested casing w/1000# pressure during 30 minute interval w/no drop in pressure prior to drilling plug. Tested casing w/1650# pressure during 30 minute interval w/no drop in pressure after drilling plug, results satisfactory. Drilling resumed.
