 Propose to squeeze present perms for recompletion in the following manner:

1. Rig up, kill well, POH w/compl assy, inst BOP.
2. RIH w/tbg thru pkr @ 7165' & spot cmt across present perms 11,686-11,712'. POH w/tbg.
3. RIH w/plug & set in pkr @ 7165'. Cap w/35' cmt.
4. Perforate 4 squeeze holes @ 4800'. Set cmt retr @ 4700'.
5. Cmt 8-5/8" x 5 1/2" csg annulus thru perms 4800' w/300 sx Cl C cmt cont'g 2% CaCl & 6# salt/sk.
