Detailed account of work done, nature and quantity of materials used and results obtained.

Spudded 11" hole 5-13-60 and drilled to 455'. Reamed to 17-1/2" hole. Ran 450' of 11-3/4" OD 42# casing w/ guide shoe set at 450'. Cemented w/ 475 sacks Portland Neat cement. Pumped plug to 420'. Maximum pressure 150#, had cement returns to surface. Waited 24 hours and tested casing and cement w/ 1000#, held OK for 30 minutes.
Drilled 455' to 3802', ran 3801' of 8-5/8" OD 32 and 21# casing w/ guide shoe set at 3801', float collar at 3735'. Cemented w/ 1564 sacks litewate and 200 sacks Neat cement. Pumped plug to 3735', maximum pressure 1000#, had cement returns to surface. Job complete 1:45 P.M. 5-22-60. 24 hours WOC, tested casing and cement with 1000#, held 30 minutes OK.
Drilled 3802' to 8421', inc.
