This well spudded 3-24-36 and drilled to depth of 69' that date in sand and shells. Two States Drilling Company, contractors.

March 25, 1936. Well drilled to total depth of 277' in Redbed. 13" OD 50# SH LW casing was set at 274' and cemented with 200 sacks.

March 28, 1936. Drilled plug and bailed 13" casing. After allowing to stand for two hours, bailer was run and hole found to be dry. Casing test OK.
