Plug back with pea gravel 6021-6015. Run 140 qts. SNG from 6015 - 5982 in 7 4" x 8' tin shells with AGDA bomb and Bolshevik Cave Catchers between second and third shells and fifth and sixth shells. Tamp with pea gravel 5982-5961 and 20 sacks Calseal from 5961 to 5851'.
