We plan to pull rods & tubing, run well surveys, set retainer at 4220' and squeeze present perforations 4230' to 4232' and 4234' to 4254' with cement, pressure test liner, perforate 4188' to 4215', acidize and test. If this zone tests water, squeeze off with cement, perforate 4140' to 4178' and test. Our intentions are to shut off water and increase production.
