DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The above described well was re-treated with 4000 gallons of Dowell XX acid.

As a result of the re-treatment the production of the well was raised from 8 barrels of oil per hour and gas at the rate of 169M per day, to 11 barrels of oil per hour with gas at the rate of 695M per day.

The above report was made from tests taken after the well had flowed seven hours and had cleaned itself of oil used to follow the acid. Water percentage was 6/10 of one percent.
