Ran 11 joints 8-5/8-inch OD 2 1/2" J-55 casing, total of 331.16 feet set at 344.22 feet. Cemented with 225 sacks 4 1/2 gel cement. Plug on bottom at 2:50 P.M., 2-28-55. Slurry weight 14.4 and 14.8#. Circulated approximately 50 sacks.

Tested casing with 1000# G.P. for 30 minutes. Test O.K. No drop in pressure. Drilled plug at 3:00 P.M., 3-1-55.
