Work began 12/21/79. Set bridge plug at 3055, perforate 5 1/2" casing 2778-82, 2810-12, 2848-50, 2880-87, 2917-19 with a total of 39 shots. Treat perfs 2778-2919 with 1500 gallons 15% regular acid, 20,000 gallons CO₂ and 10,000# sand. Swabbed load and pulled bridge plug. Set packer at 3055 & treat perfs 3610-3880 with 2,000 gallons regular acid. Swab load. Ran rods and pump. 2/6/80 pumped 1 bbl oil, 6 bbl water, 106 MCF gas in 24 hours.
