TD 4830 - Set 9 5/8" OD casing @ 4829 and cemented with 2600 sacks cement. Ran temperature survey which indicated top of cement back of 9 5/8" casing @ 1640' from surface. Let cement set 48 hours and tested with 1,000# pump pressure for 30 minutes before and after drilling plug. No decrease in pressure. Resumed drilling.
