DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

3270' TD

Loaded hole with crude oil and tested 5-1/2" OD casing with 2000 lbs. - OK. Pumped crude oil down tubing and into formation at 2700 lbs. pressure. Pulled rods, tubing, packer and holddown. Sand-oiled 4-3/4" open hole from 3180' to 3270' with 30,000 gallons of Famariss 24 gty. refined oil and 30,000 lbs. of sand. Well flowed back 665 bbls. of load oil through casing. Ran tubing, pump and rods and put well to pumping. Well pumped remaining 418 bbls. of load oil.

5-11-55 - Well pumped 15.40 bbls. of oil and 1.60 bbls. of water in 24 hours on 14 - 42" SPM.
