5-6-58 Set Baker C.I. bridge plug in 5-1/2" liner @ 4110'. Ran HOWCO RTTS tool to 900' & tested 7" casing back to 435 w/ 1000#, which held okay. Found top of hole @ 140' & bottom @ 400'. Pumped in annulus between 9-5/8" @ 7" @ 1 BPM @ 1700#. Mixed 440 sks. Reg. cement & pumped in w/ initial pressure of 1700# & final pressure of 1100#. 5 min. SIP 1000#. Job completed @ 4:10 P.M. 5-7-58.

5-9-58 Found top of cement plug in 7" casing @ 136'. Drilled hard cement to bottom of plug @ 246'. Tested 7" csg. w/ 1100# for 30 mins. w/ no drop in pressure. This test witnessed by OCC Engineer. Drilled C.I. bridge plug @ 4110' & chased to bottom. Ran tubing & rods & put well on pump May 12, 1958.
