2. Run radioactivity survey.
3. Run tubing w/5-inch HV packer & hold-down tool.
4. Set packer at approximately 100' & treat as follows:
  - a. 25 barrels of treated lease crude.
  - b. 5000 gallons 15% non-emulsifying acid.
5. Pull tubing & packer.
6. Run production string, rods & wire.
7. Run back tool & place on production.
