We have leak in the 7" OD 24# casing on this well; the pressure equalizes on 7" casing & between 7" and 9-5/8" casing. We intend to set Baker Cement Retainer below the leak, and cement with 200 Sacks. If leak is too small to cement we will perforate the casing below leak and cement thru the perforations. We expect to start this work on December 21st.
